NC Medicaid Transformation Update

Willona Stallings, Director, NC Get Covered

- Webcast with NCDHHS Secretary Mandy Cohen last Wednesday, February 6
- High level overview of what was discussed:
 - 3-year contracts (with 2 option years) awarded to 5 Prepaid Health Plans (PHPs)
 - 4 statewide – AmeriHealth Caritas, Blue Cross and Blue Shield of NC, UnitedHealthcare of NC, and WellCare of NC
 - 1 provider-led entity that will serve regions 3 & 5 only – Carolina Complete Health
 - 1.6 million Medicaid beneficiaries will be affected (standard plans only)
 - Medicaid Managed Care will launch in 2 of 6 regions this year (**See attached Managed Care Region Rollout Map**)
 - Regions 2 & 4
 - June 2019 – Beneficiaries can start selecting PHPs (with the help of an Enrollment Broker/Maximus)
 - November 2019 – Beneficiaries will start receiving services through PHPs
 - Regions 1, 3, 5 & 6
 - November 2019 – Beneficiaries can start selecting PHPs
 - February 2020 – Beneficiaries will start receiving services
 - Only thing beneficiaries need to do now is update their information.
 - Eligibility rules are the same.
 - Same services, treatments and supplies will be covered
