#### Health Care Policy Update

- The American Health Care Act would drastically restructure Medicare, phase out Medicaid expansion, and have an effect on the private market/ premium tax credits.
- Most people at risk of losing coverage under the American Health Care Act are between the ages of 50-64 and below 200% FPL.

### BCBSNC's New Health Insurance Literacy Initiative + Q&A

- When a consumer selects a Primary Care Provider, it increases their likelihood of using a Primary Care Provider.
- Limited networks will become more common to keep costs down.
- Consumers at 100-200% FPL have a harder time using insurance.
- Onboarding events planned at UNC Wayne Health (rural hospital) and Novant (urban hospital). BCBSNC will act as a matchmaker and then step out.
- Consumers will receive a \$25 gift card if they watch an educational video designed to increase their health insurance literacy. They must first sign up for Blue Connect.
- Consumers can watch the educational video on their own; they don't have to attend an onboarding event. It also doesn't matter if they're a new or old Blue Connect member.
- The information will be available in Spanish, too.

- If you are aware of other provider networks that might want to participate, please let Alec know.
- Events will take place before the next open enrollment period, hopefully by the end of April.
- In-person assisters can feel free to promote these events because they target existing Blue Cross members.
- BCBSNC can also distribute handouts or flyers but this has not proven to be an effective strategy in the past.
