### **Meeting Notes**

### **NCGC Staff Update**

- Hired Deborah Owens as NC Get Covered's ACA Project Specialist
- Working closely with NCGC Advisory Board to update strategic plan and priorities
  - Most priorities will remain the same (e.g., convening coalition members) but we'll do some long-term planning as well to address normalizing/ institutionalizing ACA outreach and enrollment in NC during times of uncertainly (e.g., shorter enrollment periods, insurance carriers entering and exiting the Marketplace, changes in U.S. Administration, etc.)
  - Creating template/sample newsletter for NCGC Advisory Board's input and consideration
- Will submit next grant proposal to the Kate B. Reynolds Charitable Trust in August.
- Presented at Enroll America's national conference in DC last week on NCGC's Latino
  Mini-grant Program i.e., the \$5k mini-grants that were awarded to Latino
  organizations during OE3 to help grow their capacity and connect them to local ACA
  resources.
  - NCGC staff will share some of the outcomes from this work at the next coalition meeting in June.
- Serving on the planning committee for this year's NC Assister Conference... A Save the Date will be sent to enrollment assister organizations soon... Please stay tuned!
- Participating in other ACA-related meetings and activities, like NC Department of Insurance's Consumer Advisory Group, Farmworker Health Insurance Team or FHIT, and Enroll America's faith-based efforts.

- PremiumHelp.org (Tiki Windley) 669 applications approved; half of funding remaining
- NC Community Health Center Association (Brendan Riley) Digesting federal policies –
  Special Enrollment Periods, non-discriminatory rule, 1115 waiver to change Medicaid
  program, etc.
- Care Share Health Alliance (Kellan Moore) Excited about the recent announcement of new Kate B. Reynolds Charitable Trust President, Laura Gerald.
- Enroll America (Sorien Schmidt) Held 3<sup>rd</sup> national conference in Washington, DC/ over 700 people attended/ NC has 4<sup>th</sup> highest enrollment numbers but 5<sup>th</sup> highest uninsured rate/ over a million people still uninsured/ a lot of churn in the Marketplace/ survey showed that people have a basic level of knowledge about the ACA but don't know what

it means for them personally/ we still need assisters/ over 80% of people felt comfortable with their assister/ Enroll America and HHS are offering a series of webinars for assisters this summer (Willona will distribute)/ House vs. Burwell – case has gone into Appeals; nothing has changed.

- Aetna (Linda Cecarelli) Getting ready for 2017
- **Legal Aid of NC (Jennifer Simmons)** Focused on grant writing/ reduction in available funding but there's enough to continue offering previous services
- Blue Cross and Blue Shield of NC (Walker Wilson) CMS will be sending notifications to consumers who haven't reconciled their taxes and enrolled in Medicaid/ can cause confusion/ advise consumers to reach out to their county's DSS office/ if they receive the notice, it doesn't mean their policy will be automatically terminated.
- Advance Community Health (Ritu Kaur & Kendra Hinton) Dealing with a lot of noshows/ Advance Community Health was not listed on the healthcare.gov website
- **UNC Wayne Health (Joe Langley) UNC** Wayne Health was one of a few hospitals that hosted an enrollment event/ discussed impact on hospitals of 501R, where they're required to aggressively make charity care available
- Alcohol/Drug Council of NC (Tiona Washington) Focused on grant writing/ participating in WRAL Balloon Fest in Fuquay Varina, May 27-30
- NC Department of Insurance (Carla Obiol & Melinda Munden) Held Consumer
  Advisory Group meeting on yesterday/ put together a Network Advisory Group/ will
  hold three meetings in June with consumer advocates, providers and insurance carriers
  to get their feedback/ will keep NCGC briefed/ there's room in the model to make
  changes or tweaks/ NC DOI will receive NC Community Health Center Association's
  Service Award/ SHIIP continues to see incorrect information from the Marketplace/ just
  finished grant writing/ hosting Medicare Town Hall meetings/ acknowledged NCCHCA
  for putting SHIIP materials in their sites
- Health Purchasers and Consumers Together (Andy Landes) Coalition for Health Care
  of North Carolina interested in Medicaid expansion, not just a petition but doing the
  groundwork/ need collective and cooperative action on this/ educational forum about
  different health care system approaches/ Health Literacy Coalition fell by the wayside
- Mountain Projects, Inc. (Jan Plummer) Involved in Special Enrollment Period/ helping people not have reconciliation problem/ meeting in western NC on June 7 – focusing on SEPs for folks with increase in income/ partnered with Lion's Club – visual mobile van/ faith-based outreach/ focused on understanding charity care/ DOI has been helpful

## **Network Adequacy: NAIC Model 74**

- This all began in 1997; insurers have the responsibility to determine network
- Greater degree of scrutiny by Feds on network adequacy but will allow states to decide what provider network adequacy should look like
- Information from Feds will serve as starting point for state discussions
- Qualified Health Plans will have to meet federal standards/ some leniency in 2017
- Medicare Advantage plans are the model
- Aetna, BCBS and Cigna would like to participate in NC's Marketplace (can change their minds through October)
