
Comments:

- HMO, so no OON (unless Emergency)

Cigna – Open Enrollment 2018



Comments:

- Majority of customers are in Wake County (Raleigh)
- Approximately 90% of customers are eligible for Advanced Premium Tax Credit (subsidy to pay monthly premium)
- Approximately 2/3 of customers choose Cost-Share-Reduction Plans

Cigna – 2018 Open Enrollment

- 2018 Open Enrollment was considerably shorter than previous years. However, no matter how it's sliced, people are going to wait until the last day to sign up
- In North Carolina, this was Cigna's 2nd year in the ACA, but Cigna has been in the ACA in other markets since it's inception.
- Cigna experienced minimal questions on access to care. Cigna actually experienced very few customers issues during 2018's Open Enrollment and issues that did pop were resolved quickly.
- Customer complaints are tracking much lower this year.
- Not surprisingly, Cigna did have very high call volume on January 2, this was the day that premiums were due for renewals.
