AMA and hospital staff noticed a correlation between the work we were doing with Medicaid Screening and what we <u>believed</u> the work would be to assist a self-pay patient in the ACA enrollment process The ACA application process turned out to be much more time consuming and required much more follow-up than our staff could handle given the limited amount of time that they had with each patient

AMA and hospital staff decided to continue screening patients for Medicaid and push ACA enrollment candidates to our local FQHC **Goshen Medical Center** who had a office across the street from the hospital

How do we know if the enrollment event by itself was a cost effective tool for facilitating insurance enrollment through the ACA?

AMA staff reviewed all of those who enrolled at either ACA event and comparisons were made using only information that was obtain by ACA staff which was name, phone and whether or not they were able to sign-up that day for a plan. This limited data was compared to hospital demographic data. Those who could be identified as a match to the demographic data were then examined to see if they had been admitted to the hospital and covered by an ACA plan after being enrolled at their respective event

ED Visits for last two fiscal years significantly down

Bad and Charity care are also significantly down
