How can we expand on this definition? What else could there be to add or consider in the context of your work?




Centering Health Equity – A Health Equity Roadmap

- Root Causes – Racism (cultural, structural, personal), Wealth/Income Inequality, Privilege
- Action – Increased access, collaboration, education, bi-directional learning
- Values Alignment and Visioning – prioritize and strategize
- Evaluation and Assessment – internal/external levels, process > destination
